RESOLUTION 22-222

Resolution of Mayor and Council of Princeton Rejecting Bids for 2022 Tree Removal Project and Authorizing Re-Advertising for Bids

WHEREAS, after proper notice and advertisement pursuant to the provisions of the New Jersey Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1 <u>et seq.</u>, on June 16, 2022 the Municipality of Princeton received three (3) bids for the "2022 Tree Removal Project," and as follows:

1. Omar and Justins Inc. t/a
Justin Tree Services & Lawn Care \$138,700.00

US Athletic Fields, Inc. \$169,105.00
 Dom's Lawnmaker, Inc. \$250,390.00; and

WHEREAS, the bid submitted by the first bidder Justin Tree Services & Lawn Care omitted a Consent of Surety, which was a mandatory, non-waivable requirement for bidding, which renders this bid non-conforming; and

WHEREAS, the second bidder US Athletic Fields, Inc. did not include its EMR (Experience Modification Rate), which was a mandatory, non-waivable requirement for bidding, which renders this bid non-conforming; and

WHEREAS, the third bidder Dom's Lawnmaker, Inc. did not submit documentation evidencing that it is a New Jersey licensed tree expert or New Jersey licensed tree operator, which was a mandatory, non-waivable requirement for bidding, which renders this bid non-conforming; and

WHEREAS, even if the bid submitted by Dom's Lawnmaker, Inc. was a conforming bid, its bid amount substantially exceeds Princeton's estimates and appropriation for the goods or services; and

WHEREAS, the Local Public Contracts Law requires the rejection of unresponsive and nonconforming bids and bids which contain material, non-waivable defects; and

WHEREAS, the Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-13.2a. and b. authorizes the rejection of bids which substantially exceed the cost estimates and appropriation for the goods and services.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of Princeton, County of Mercer, State of New Jersey, as follows:

- 1. The three (3) bids received on June 16, 2022 for the "2022 Tree Removal Project" are hereby rejected on the basis that the three bids are nonconforming and unresponsive, for the reasons set forth in the "Whereas" clauses.
- 2. The bid submitted by Dom's Lawnmaker, Inc. is also rejected on the basis that it

- substantially exceeds the municipality's cost estimates and appropriation for the goods and services, as permitted by N.J.S.A. 40A:11-13.2a. and b.
- 3. Municipal staff is hereby authorized and directed to update the bidding documents as may be necessary for the 2022 Tree Removal Project and re-advertise same.
