**RESOLUTION 19-78**

**Resolution Authorizing the Memorandum of Understanding between the Municipality of Princeton, Princeton First Aid and Rescue Squad and the Princeton Fire Department Concerning Rescue Response Protocol Policy**

**WHEREAS**, the Director of the Princeton Department of Emergency & Safety Services has conferred with representatives from Princeton First Aid and Rescue Squad (“PFARS”) and the Princeton Fire Department (“PFD”) in order to develop a rescue response protocol policy for the Princeton Community; and

**WHEREAS**, PFARS and PFD wish to memorialize the Rescue Response Policy in the form of a Memorandum of Understanding (“MOU”); and

**WHEREAS**, the parties have met and have recommended that the Mayor and Council authorize said MOU.

**NOW, THEREFORE, BE IT RESOLVED** by the Princeton Council as follows:

1. The Mayor and Clerk of Princeton hereby authorized and directed to enter into a MOU with PFARS and PFD to establish for the Princeton Community a rescue response policy protocol. The MOU hereby authorized is on file in the Office of the Municipal Clerk and may be inspected during regular office hours.
2. A certified true copy of this resolution shall be furnished by the Municipal Clerk to the Princeton Director of the Department of Emergency & Safety Services, the Princeton First Aid and Rescue Squad and the Princeton Fire Department.
