



RESOLUTION 19-105

Resolution Authorizing a Construction Contract with Top Line Construction Corporation in the Not to Exceed Amount of \$39,006.90 for the Construction of Curbing and Other Incidental Work for the Closure of Terhune Road and Along the US Route 206 Frontage of the New Princeton First Aid and Rescue Squad Site

WHEREAS, the Engineering Department requested quotes for purposes constructing curbing and other incidental work across Terhune Road and along the US Route 206 frontage of the new Princeton First Aid and Rescue Squad site on behalf of Princeton; and

WHEREAS, Princeton received two (2) quotes to undertake and complete said work:

1. \$39,006.90 by Top Line Construction Corporation, Somerville, NJ;
2. \$54,971.00 by S. Brothers Inc., South River, NJ; and

WHEREAS, Top Line Construction Corporation provided the low bid quote for purposes of performing the sought-after construction services for the not to exceed contract amount of \$39,006.90; and

WHEREAS, this contract award is exempt from public bidding pursuant to N.J.S.A. 40A:11-3(a) and 40A:11-6.1(a) because the contract amount is below the bid threshold of \$40,000.00 for municipalities with a Qualified Purchasing Agent; and

WHEREAS, Top Line Construction Corporation will complete and file with the Municipality a Business Entity Disclosure Certification as required by N.J.S.A. 19:44A-20.2 *et seq.* certifying that it has not made any prohibited contributions to a candidate committee or municipal committee representing the elected officials of the Municipality of Princeton, along with a Political Disclosure Contribution Form as required by N.J.S.A. 19:44A-20.26; and

WHEREAS, Princeton has appropriated sufficient funds for this project in capital

account # 04-215-17-037-076-325, as certified by Sandra Webb, Chief Financial Officer; and


WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned Contractor with the lowest responsible quote.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Municipality of Princeton as follows:

1. The Mayor and Clerk are hereby authorized and directed to enter into a contract with Top Line Construction Corporation, Somerville, NJ (hereinafter referred to as "Contractor") for construction services consistent with this Resolution and the above "Whereas" clauses.
2. Top Line Construction Corporation, Somerville, NJ shall be paid a fee not to exceed \$39,006.90.
3. A copy of this Resolution, the Pay-to-Play Forms and the agreement shall be placed on file in the Office of the Clerk.
