**Resolution Approving the Agreement to Custom Care Services, Inc.  
for Mowing Services-A Not to Exceed \$29,355.00**

WHEREAS, Princeton has advertised for and received bids in accordance with the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11-1 et seq.* for mowing and trimming services of specified grass areas at Farmview Fields, Greenway Meadows, Community Park North, Mt Lakes Lower Earthen Dam, Marquand Park, Turning Basin and the Monument Hall Municipal Complex; and

WHEREAS, Princeton has received one (1) bid to undertake and complete said work; and

WHEREAS, in reviewing said bids Princeton has determined that the lowest responsible bidder for the above referenced mowing services to be Custom Care Services, Inc. Wall, NJ in the amount of \$29,355.00; and

WHEREAS, Princeton has appropriated funds for this service as certified by the Chief Financial Officer and per the Account 01-201-28-375-273 Park Maintenance-Other Contractual Services; and

WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible, responsive bidder.

NOW, THEREFORE, BE IT RESOLVED by the Princeton Council and the Municipality of Princeton as follows:


1. The Mayor and Clerk of Princeton are hereby authorized and directed to enter into an agreement with Custom Care Services, Inc. of Wall, NJ for a sum not to exceed \$29,355.00 to provide mowing and trimming services of specified grass areas at Farmview Fields, Greenway

Meadows, Community Park North, Mt Lakes Lower Earthen Dam, Marquand Park, Turning Basin and the Monument Hall Municipal Complex.
