**Resolution Authorizing the Award of the Contract Known as
"Princeton Spring 2019 Planting Project" to Sunset Creations, Inc." in
the amount of \$24,990.00**

WHEREAS, the Municipality of Princeton has solicited bid proposals for tree planting at various locations within the Municipality of Princeton for Spring 2019; and

WHEREAS, all bid proposals were opened on March 28, 2019; and

WHEREAS, Princeton received the following bids:

Sunset Creations, Inc., Belle Mead, New Jersey in the amount of \$24,990.00;

Wetlands, Inc., Saddle Brook, New Jersey in the amount of \$36,975.00;

Rusling Paving & Concrete, Trenton, New Jersey in the amount of \$44,115.00 and

WHEREAS, it is the recommendation of the Director of Infrastructure and Operations that the contract be awarded to Sunset Creations, Inc., 355 Route 601, Belle Mead, New Jersey 08502 as the lowest responsible bidder; and

WHEREAS, Princeton's Chief Financial Officer has certified that sufficient funds in the total amount of \$24,990.00 are available for this project as follows:


NOW, THEREFORE, BE IT RESOLVED by the Council of the Municipality of
