**RESOLUTION 19-137**

**Resolution Authorizing the Award of a Contract to Straight Edge Striping of Bound Brook, New Jersey in the Not to Exceed Amount for \$37,116.00 for Pavement Markings and Striping Services in Various Locations on Municipal Roads and Parking Lots**

**WHEREAS**, the Municipality of Princeton has a need to retain the services of a qualified contractor for purposes of installing pavement markings and line striping on municipal roadways and parking lots; and

**WHEREAS**, the Engineering Department solicited quotes for said services and received prices from four vendors as detailed in the attached quote tabulation; and

**WHEREAS**, Princeton received four (4) quotes to undertake and complete said work:

1. \$37,116.00 by Straight Edge Striping LLC., Middlesex, New Jersey
2. \$43,444.00 by Traffic Lines Inc., Farmingdale, New Jersey
3. \$61,384.75 by Zone Striping Inc., Glassboro, New Jersey
4. \$73,130.00 by Denville Line Painting Inc., Rockaway, New Jersey; and

**WHEREAS**, Straight Edge Striping, LLC of Middlesex, New Jersey submitted the lowest quote to complete said construction services in the amount not to exceed \$37,116.00; and

**WHEREAS**, this award is exempt from public bidding pursuant to N.J.S.A. 40A:11-3(a) and 40A:11-6.1(a) because the contract amount does not exceed the bid threshold; and

**WHEREAS**, Straight Edge Striping, LLC has completed and filed with Princeton the required Campaign Contributions Affidavit pursuant to N.J.S.A. 19:44A-20.8, Certification Regarding Political Contributions pursuant to N.J.S.A. 19:44A-20.26 and affidavit pursuant

section 2-87 of the Princeton Code (collectively, the “Pay-to-Play Forms”); and


**WHEREAS**, the Chief Financial Officer has certified that sufficient funds are available in capital accounts #04-215-15-007-075-324, #04-215-16-020-075-330, #04-215-16-020-076-345, #04-215-16-020-076-346, #04-215-17-037-076-324, and #04-215-17-037-076-325 to pay for said services.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Municipality of Princeton as follows:

1. The Mayor and Clerk are hereby authorized and directed to enter into a contract with Straight Edge Striping, LLC for construction services as set forth in the foregoing “Whereas” clauses for a sum not to exceed \$37,116.00.
2. The work shall be completed as mutually agreed between the parties, the term of which shall not exceed thirty (30) days from issuance of a Notice to Proceed.
3. A copy of this Resolution, the Pay-to-Play Forms and the Agreement shall be placed on file in the Office of the Clerk.
