



RESOLUTION 19-138

Resolution Authorizing a Construction Agreement with Integrated Construction and Utilities of New Jersey (ICUNJ) in the Not to Exceed Amount of \$2,747,310.50 for Improvements to Linden Lane and Spruce Street, Contingent Upon Concurrence by the New Jersey Department of Transportation, the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust

WHEREAS, Princeton has advertised for and received bids in accordance with the provisions of the New Jersey Local Public Contracts Law, *N.J.S.A. 40A:11-2 et seq.* for Improvements to Linden Lane and Spruce Street; and

WHEREAS, in connection therewith Princeton has received the following four (4) bids on April 11, 2018:

1. \$2,747,310.50 by Integrated Construction and Utilities of New Jersey - Edison, New Jersey
2. \$3,060,069.69 by Black Rock Enterprise Inc. - Old Bridge, New Jersey
3. \$3,704,157.78 by S. Brothers Inc. - South River, New Jersey
4. \$3,864,413.13 by Earle Asphalt Company - Farmingdale, New Jersey to undertake and complete said work; and

WHEREAS, in reviewing said bids, Princeton has determined that the lowest responsive and responsible bidder is Integrated Construction and Utilities of New Jersey of Edison, New Jersey in the amount of \$2,747,310.50; and

WHEREAS, Princeton has appropriated funds for this capital project which include the receipt of the New Jersey Department of Transportation Fiscal Year 2016 Municipal Aid Grant in the amount of \$275,00.00; and

WHEREAS, Princeton has appropriated funds for this capital project which include the receipt of loan funds from the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust; and

WHEREAS, Princeton has appropriated sufficient funds for this project in capital accounts 04-215-16-020-076-359, 04-215-16-020-076-361, 04-215-16-022-089-301, 04-215-15-007-076-351, and 04-215-18-004-089-301 as certified by Sandra Webb, Chief Financial Officer; and

WHEREAS, Princeton wishes to award a contract to undertake and complete said work to the aforementioned lowest responsible bidder.

NOW, THEREFORE, BE IT RESOLVED by the Princeton Council and the Municipality of Princeton as follows:

1. The Mayor and Deputy Municipal Clerk of Princeton are hereby authorized and directed to enter into an agreement with Integrated Construction and Utilities of New Jersey of Edison, New Jersey for a sum not to exceed \$2,747,310.50; to undertake and complete Improvements to Linden Lane and Spruce Street, all in accordance with the terms and conditions with the Bid Documents which are on file in the office of the Clerk.

2. The award of this contract is being made subject to the review, approval and concurrence by the New Jersey Department of Transportation in accordance with said Department's Local Municipal Grant Program.


3. The award of this contract is being made subject to the review, approval, and

concurrence by the New Jersey Department of Environmental Protection and the New Jersey Environmental Infrastructure Trust in accordance with Infrastructure Trust funding requirements.

4. A certified true copy of this Resolution shall be furnished upon its adoption to the New Jersey Department of Transportation, and Integrated Construction and Utilities of New Jersey of Edison, NJ.
