



RESOLUTION 19-160

Resolution Authorizing an Agreement with the Washington Oaks Homeowners Association, Inc. for the Reimbursement of \$32,916.62 for Private Services Performed in 2018 Under the New Jersey Municipal Services Act

WHEREAS, the New Jersey Municipal Services Act, *N.J.S.A. 40:67-23.2 et seq.* requires municipalities to provide certain services or reimbursement for those certain services to Qualified Private Communities as defined in the Act; and

WHEREAS, the Municipality of Princeton has chosen to provide some of said services directly and reimburse the Qualified Private Communities for other municipal services rather than provide services directly; and

WHEREAS, Washington Oaks Homeowners Association, Inc. (“Washington Oaks”) is a qualified private community as defined in the Act; and

WHEREAS, the Municipality of Princeton wishes to enter into a new Municipal Services Agreement with Washington Oaks to give reimbursement for 2018 and for prospective reimbursement under the Municipal Services Agreement for future years; and

WHEREAS, the Chief Financial Officer has certified that sufficient funds are available for this payment in account 01-203-26-325-635; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Princeton as follows:

1. The Mayor and Clerk of the Municipality of Princeton are hereby authorized and directed to enter into a Municipal Services Agreement with Washington Oaks in

order to reimburse that Association for snow removal, brush and leaves removal, salting and sanding, and trash collection as reviewed and determined by Princeton's Municipal Engineer. The Agreement authorized by this Resolution is on file in the Princeton Clerk's office and may be inspected during regular office hours.

2. The Municipal Committee hereby further authorized reimbursement to Washington Oaks for said municipal services for the year of 2018 in the total amount of \$32,916.62
3. Upon its adoption, a certified true copy of this Resolution together with the Municipal Services Agreement shall be furnished by the Municipal Clerk to Michael S. Karpoff, Esq., 21 Roszel Road, P.O. Box 5226, Princeton, New Jersey 08543, attorney for Washington Oaks.
